AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE CITY OF WALLIS, AUSTIN COUNTY, TEXAS, AND EXTENDING THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY WITHIN THE CITY LIMITS, AND GRANTING TO SAID TERRITORY AND TO ALL FUTURE INHABITANTS OF SAID PROPERTY ALL OF THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID FUTURE INHABITANTS BY ALL OF THE ACTS AND ORDINANCES OF THE SAID CITY.

WHEREAS, a petition for annexation has been duly signed and acknowledged by each and every person or corporation having an interest in the following described territory, to-wit:

That certain tract of land described by metes and bounds on the attached Exhibit "A".

WHEREAS, said tract of land is contiguous and adjacent to the City of Wallis, Texas, and is not more than one-half (1/2) mile in width, and

WHEREAS, said petition was presented to the City Council on the //th day of ugust, 1978, such date being not less than five (5) and not more than thirty (30) days from the date hereof, and

WHEREAS, after hearing such petition and the arguments for and against the same the City Council has voted to grant such petition and to annex said territory to the City of Wallis, Texas;

NOW THEREFORE, be it ordained by the City Council of the City of Wallis, Texas:

That the following described property, to-wit:

be and the same is hereby annexed to the City of Wallis, Austin County, Texas, and that the boundary limits of the City of Wallis, Texas, be and the same are hereby extended to include the above described territory within the city limits of the City of Wallis, Texas, and the same shall hereafter be included within the territorial limits of said city, and said land and the future inhabitants thereof shall hereafter be entitled to all rights and privileges of other citizens of the City of Wallis, Texas, and shall be bound by the acts and ordinances of said city.
