

ORDINANCE NO. 126

AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE CITY OF WALLIS, AUSTIN COUNTY, TEXAS, AND EXTENDING THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY WITHIN SAID CITY LIMITS, AND GRANTING TO ALL THE INHABITANTS OF SAID PROPERTY ALL OF THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID INHABITANTS BY ALL OF THE ACTS, ORDINANCES, RESOLUTIONS AND REGULATIONS OF SAID CITY.

WHEREAS, a petition has been signed by a majority of the property owners who are citizens of the State of Texas and inhabitants of the following described territory, to-wit:

A 12.0968 acre tract of land being a part of the Mrs. Judith Hranicky Original Call 54.00 acre tract in the Milburn and Davis League, Abstract 71, Austin County, Texas, being a part of that same tract as described in Deed recorded in Volume 204, Pages 268-271, Austin County Deed Records, said tract of land being more particularly described by metes and bounds on Exhibit "A", attached hereto and made a part hereof.

WHEREAS, said petition, desiring and requesting the annexation of said territory to said City, has been presented to the City Council and has attached to it the affidavit of three (3) of said applicants to the effect that said petition is signed by a majority of the qualified voters within such property;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WALLIS, TEXAS:

That the following described property, to-wit:

A 12.0968 acre tract of land being a part of the Mrs. Judith Hranicky Original Call 54.00 acre tract in the Milburn and Davis League, Abstract

71, Austin County, Texas, being a part of that same tract as described in Deed recorded in Volume 204, Pages 268-271, Austin County Deed Records, said tract of land being more particularly described by metes and bounds on Exhibit "A", attached hereto and made a part hereof;

be and the same is hereby annexed to the City of Wallis, Austin County, Texas and that the boundary limits of the City of Wallis, Texas be and the same are hereby extended to include the above described territory within the territorial limits of said City, and the inhabitants thereof shall hereafter be entitled to all rights and privileges of other citizens of the City of Wallis, Texas and they shall be bound by the acts, ordinances, resolutions and regulations of said City.


The City Clerk is hereby directed to file with the County Clerk of Austin County, Texas, a certified copy of this Ordinance.
