- b. Downtown Revitalization Project Update Project is completed, however during final walk throughs, cracks were noticed in the sidewalk believed to be from standing water in form when concrete was poured. There will be another walkthrough in three months to check on size of

cracks. Project has a one-year warranty, this will be set as a warranty issue.

- c. Water Well #1 Mayor Little went over update as presented in packet
- d. TWDB Water/Wastewater Grant PIF's were accepted, applications cannot be submitted until PIF record status has been changed to invited status.
- e. Battery Farm Update- Still waiting on Safebuilt to complete the plan review, City is not getting a response from Safebuilt on the review after several attempts by Marti Frost and Mayor Little. City will submit plans for review to Bureau Veritas.
